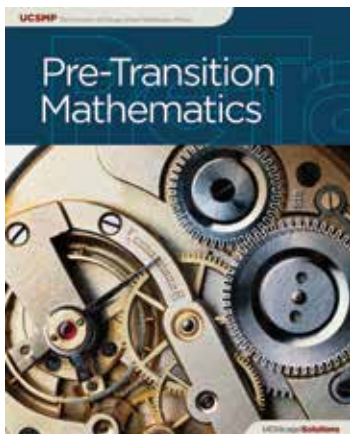

## Welcome to the UCSMP Online Student Edition

Thanks for purchasing the all-new Online Student Edition of *Pre-Transition Mathematics*. We've partnered with a leading online publishing platform to provide your students with the latest interactive features, such as the ability to access the book on virtually any device, including smartphones.



## Key Features of the Online Student Edition

There are a few key elements of your school's account and UCSMP's online subscription management system to remember:

**Our online platform operates on an August 1 to June 30 calendar.**

- Contact us if your school is open year-round or you need summer-school access.

**Your subscriptions are active and available to you for six school years.**

- Access will end on June 30th of the sixth school year after purchase.

**You will need to reactivate subscriptions every year.**

- This allows you to manage usage for annual changes in class size.
- Reactivation clears electronic highlights and annotations made by last year's students.

**Allow up to 3 hours for completion of the entire activation process.**

## What You Need

Before you begin, please gather the following information:

- Your official school email address** (no public email domains such as gmail or yahoo).
  - An email with the school domain name allows us to validate your authority to activate and manage subscriptions.
- The latest available headcount for your class sections.**
  - Activate only the number of subscriptions you are certain you will need, especially if you are teaching a subject with other teachers.
  - You can always come back and activate additional subscriptions.
- An invoice or packing slip from your school's purchase of Online Student Editions.**
  - Identification numbers from your order are required in order to validate and track your subscriptions.
  - If you don't have access to either document, contact your school's office or finance department for a copy.

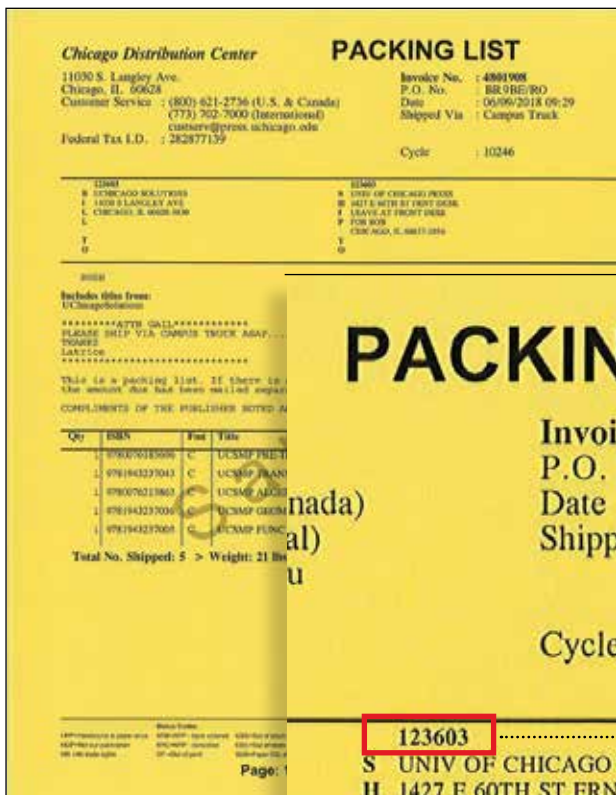

# Activating Online Student Editions

The activation and subscription management process is managed through a web browser interface. Go to [www.ucsmptdigital.com](http://www.ucsmptdigital.com) and complete these steps—



## On your first visit to the homepage:

- Click on the “First-time user click here” button.
- You will be redirected to the registration page. Using the Customer Number, create a new account for yourself.

## On subsequent visits, stay on the homepage and enter your login information.

### You will be redirected to the order authorization page.

- Here you can add Invoice Numbers to gain access to available Online Student Edition subscriptions.
- Previously activated orders will automatically appear.

### The page will also display currently available titles and remaining quantities.

- Select the book(s) you are activating online subscriptions for and the number you need of each title.

### The system will generate printable sheets of each student userID and initial password.

- You can print the forms right from the browser for distribution to students in the classroom.

### A confirmation email summarizing your activity will be sent to you within 3 hours.

# Frequently Asked Questions

---

**Q: Are UCSMP Online Student Editions available for download or offline use?**

**A:** Students using a web browser must be on an active internet connection. On a tablet or smartphone, the mobile app retains recently viewed lessons or chapters in order to reduce data plan usage so students do have limited offline access on these devices.

---

**Q: What happens to subscriptions that aren't activated?**

**A:** Like unused textbooks, subscriptions that are not activated are available to you at any time should new students join your class.

---

**Q: I activated too many subscriptions. Can I deactivate them?**

**A:** This capability is in development and should be available in early 2017. Until then, we recommend forwarding the extra accounts to a colleague teaching the same class. If that's not a practical option then treat the unused student accounts like any valuable online account data and keep the information in a safe location.

---

**Q: Enrollment has increased and we are out of subscriptions. What are our options?**

**A:** Your school will need to purchase additional online subscriptions using the same process as your previous order. Online Student Edition subscriptions cannot be purchased through [ucsmptdigital.com](http://ucsmptdigital.com).

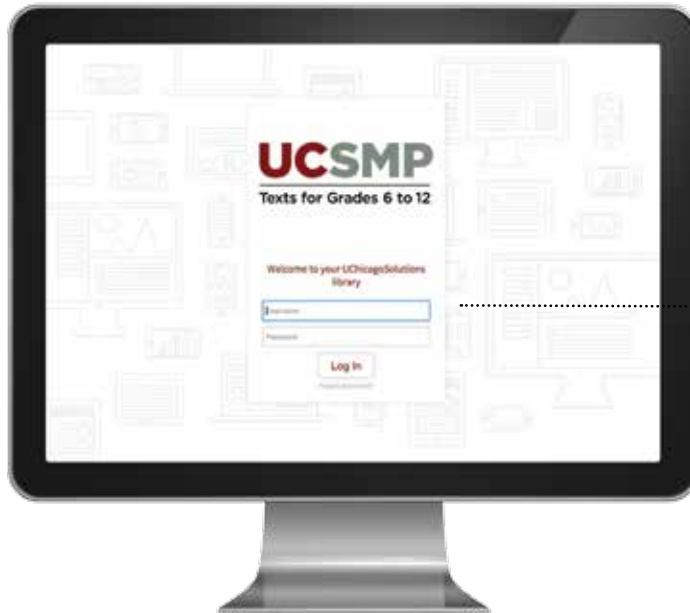
**Q: Is there any remedy if a student loses their account information?**

**A:** If the student hasn't opened their account yet we can provide a new student account in about 24 hours. If the student account is live we will need your assistance to determine the student's account information as we do not collect any student's personal information. We suggest distributing student accounts in alphabetical order so you can quickly identify the relevant account.



## Opening Student Accounts

Students will open their accounts and access their Online Student Edition textbooks at [ucsmpr.read.inkling.com](http://ucsmpr.read.inkling.com). Note that the system is optimized for the [Chrome browser](#)!



At the homepage, students will enter their unique userID and password from the PDF instructions they received in class.



Students will be redirected to their online UCSMP library homepage.

Click on the book cover icon to open the textbook.

Clicking on the silhouette in the upper right corner allows students to change their passwords or to logout.

# Using the Mobile Application

Students can use the Inklings mobile application for iOS or Android on tablets and smartphones.

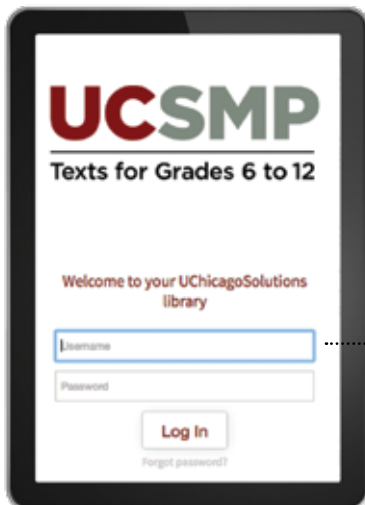
**Using your device in the App Store or on Google Play, search for “Inklings” (do NOT select “Inklings eBooks”).**

Download and install the application.



**The first time the app is opened students will be asked for a company code.**

**Everyone should type in “ucsmp”.**  
(This is a one-time step that does not have to be repeated.)



**A login screen will appear.**

**Students should type in the userID and password from the activation document.**

**The application will open the library homepage.**

- Click on the book cover icon to open the textbook.

## Getting the Most from the Online Edition

The UCSMP Online Student Edition platform will probably be new to your students. Here are a few simple exercises you can assign as “homework” to ensure that students learn how to get the most from the system:

### Getting information from Popups—

- Find and click on vocabulary terms and copy the definitions.

### Using the Search function—

- Use the search bar to find a theorem or person and note the location of the first result.

### Follow a Lesson Link—

- Some lessons refer to supporting material in other lessons. Students will record the location the link takes them to.

### Highlighting—

- Electronically highlight a passage.

### Annotation—

- Attach a sticky note to a particular lesson or problem.

## Differences Between the Print and Online Editions

The Online Edition dynamically adjusts the size and scale of the text and images to fit the screen and device. Certain problems and exercises requiring measurements of distance and angle on the printed page cannot be completed using the Online Edition.

# Terms and Conditions

## AGREEMENT FOR SUBSCRIPTIONS TO ELECTRONIC VERSIONS OF UCSMP TEXTBOOKS

Subject to payment of the specified subscription fee and to the terms of this Agreement, The University of Chicago (“University”) grants the purchasing person or organization (the “Licensee”) a non-exclusive and non-transferable license of rights as described herein to access the electronic student edition of certain mathematics texts (the “Licensed Textbooks”) during the specified term of subscription.

THIS AGREEMENT DOES NOT CONFER TO LICENSEE ANY TITLE, OWNERSHIP, OR COPYRIGHT TO THE LICENSED TEXTBOOKS OR ANY PORTION THEREOF. ALL RIGHTS NOT EXPRESSLY GRANTED BY THIS AGREEMENT ARE RESERVED BY THE UNIVERSITY AND ANY THIRD PARTY FROM WHICH THE UNIVERSITY HAS LICENSED MATERIAL FOR INCLUSION IN THE LICENSED TEXTBOOKS.

### ACCEPTANCE OF TERMS

Activation of copies of the Licensed Textbooks by creating one or more usernames and initial passwords on the website at [www.ucsmptdigital.com](http://www.ucsmptdigital.com) shall indicate that the Licensee has accepted the terms of this Agreement.

### USERS

“Authorized Users” are members of Licensee limited to teaching staff (whether permanent or visiting), employees, students; and any on-site users of the Licensee’s library and computer network facilities.

The Licensee is responsible for safeguarding the username and password assigned to each Authorized User.

### INKLING PLATFORM

Access to the Licensed Textbooks is provided by a third party, Inkling Systems, Inc. (“Inkling”) through its proprietary technology platform (the “Inkling Platform”). Licensee’s and its Authorized User’s use of the Inkling Platform is subject to the terms and conditions of Inkling’s Platform Guidelines, accessible at: <https://www.inkling.com/terms/platform-guidelines-february-2016/> (the “Inkling Guidelines”).

Among other things, the Inkling Guidelines set forth the following requirements:

- Authorized Users will not share User IDs (as defined in the Inkling Guidelines) with any other person;

### PERMITTED USES

Authorized Users with a current subscription for the Licensed Textbooks may utilize available features of the Inkling Platform to access and view content, perform searches, highlight text, and insert electronic notes for their personal non-commercial use. Any search results, highlights, and electronic notes are maintained for convenience during each school year and will be deleted each June 30.

Authorized Users may not display, distribute, manipulate, save, or print any substantial portion of the Licensed Textbooks. Authorized Users may not use the Licensed Textbooks to prepare derivative works, re-publish, or otherwise re-produce any portion of the Licensed Textbooks beyond the provisions of fair use without acquiring additional permission from the University.

# Terms and Conditions (cont'd.)

## ACCESS AND AVAILABILITY

The University will make reasonable efforts to ensure that the Licensed Textbooks are available on a 24-hour basis, excluding normal network administration and system down time. If access is suspended or interrupted, the University's liability will be limited to attempting to restore access when practicable.

Notwithstanding anything to the contrary in this Agreement, the University will have no liability as a result of any inability to access the Licensed Textbooks as a result of the unavailability, inoperability, or other cause arising from or relating to the Inking Platform.

Any inability to access the Licensed Textbooks caused by conditions beyond the University's control including, but not limited to, Acts of God, government restrictions, wars, insurrections, strikes, fires, floods, power failures, network outages, work stoppages, or damage or destruction of any facilities or services, will not be considered a violation of the terms of this Agreement.

The University will have no liability for any loss or damage arising out of use or inability to use the Licensed Textbooks.

## FEEDBACK AND COMMENTS

By submitting to the University or Inking any unsolicited suggestions, enhancement requests, comments, feedback or other input relating to the Licensed Textbook or the Inking Platform or services ("Feedback"), Licensee and its Authorized Users hereby grant to Licensee and Inking a royalty-free, worldwide, transferable, sublicenseable, irrevocable, perpetual license to use or incorporate such Feedback into the Licensed Textbooks and Inking Platform and services in any manner.

## PRIVACY POLICY

The University does not ask for, discourages disclosure of, and will not retain or use the personal information of students or any minors. We do collect certain personal information of teaching staff and employees Licensees designate to activate, manage, or deactivate individual usernames and subscriptions on the [www.ucsmptdigital.com](http://www.ucsmptdigital.com) web site.

Personal information we collect is stored in our secure databases. We will occasionally use this information to contact you about your subscriptions or to tell you about new products and services. The University will not disclose any personal information to any third party unless required by law, regulation, or judicial order; provided, however, the University may disclose such information to Inking in connection with the University's and Licensee's use of the Inking Platform.

A cookie is a small piece of data sent from a web site and stored in a user's web browser while the user is browsing that web site. We use cookies on the [www.ucsmptdigital.com](http://www.ucsmptdigital.com) web site, but cookies are not connected to any personally identifiable information you submit while on the site.

The University may update this privacy policy to reflect changes to its information practices. If we make any significant changes, you will be alerted via a notification on our web site.

Licensee's data may be subject to Inking's additional terms, conditions, and policies. Licensee may access these policies by contacting Inking or accessing Inking's website.

## RESPONSIBILITY FOR AUTHORIZED USERS

Licensee shall be responsible for any violation of the terms of this Agreement by anyone who accesses the Licensed Textbooks using an Authorized User's username and password, including any violation of the Inking Guidelines.

## CONDITIONS GOVERNING THIS AGREEMENT

Licensee represents and warrants that it has all the rights necessary to enter into and perform this Agreement.

Licensee will indemnify, defend, and hold the University harmless from and against any claim, liability, loss, or damage (including attorneys' and consultants' fees) arising out of any claim brought, made, or alleged against the University that, if true, would have resulted, in whole or in part, from a violation of the terms of this Agreement or the Inking Guidelines by Licensee, any Authorized User, or any person accessing the Licensed Textbooks using an Authorized User's username and password.

The specific terms of this Agreement and the business discussion relating to Licensee's subscription to the Licensed Textbooks shall be held confidential, including information which is or should be reasonably understood to be confidential or proprietary to the discloser of the information. This confidentiality shall survive termination of the subscription.

This Agreement will be governed by the laws of the State of Illinois and the United States of America, and will be deemed to be executed in and performed solely in the State of Illinois. To the extent permitted by applicable law, the parties agree that all actions and proceedings between the parties arising out of or related to this Agreement shall be brought only in a state or federal court located in Cook County, Illinois, and the parties hereby consent to such venue and to the jurisdiction of such courts over the subject matter of such proceeding and themselves.
